On 10-13-2019, at 1459, JSO patrol officers were dispatched to 1393 Kings Road (Sunoco Gas Station) in reference to a person being shot. The victim was located near the front entrance of the gas station with multiple gunshot wounds. The victim was transported to UF Health hospital where he succumbed to his injuries and was pronounced as deceased at 1550 by medical staff. The Medical Examiner later ruled the investigation a homicide. During the investigation the listed suspect was later identified by two witnesses.

On 10-16-2019, a warrant was obtained for the listed suspect.

On 10-21-2019, the suspect was located and brought to the Police Memorial Building for questioning. During the interview the suspect declined to speak with police and was transported to the PTFD without incident.

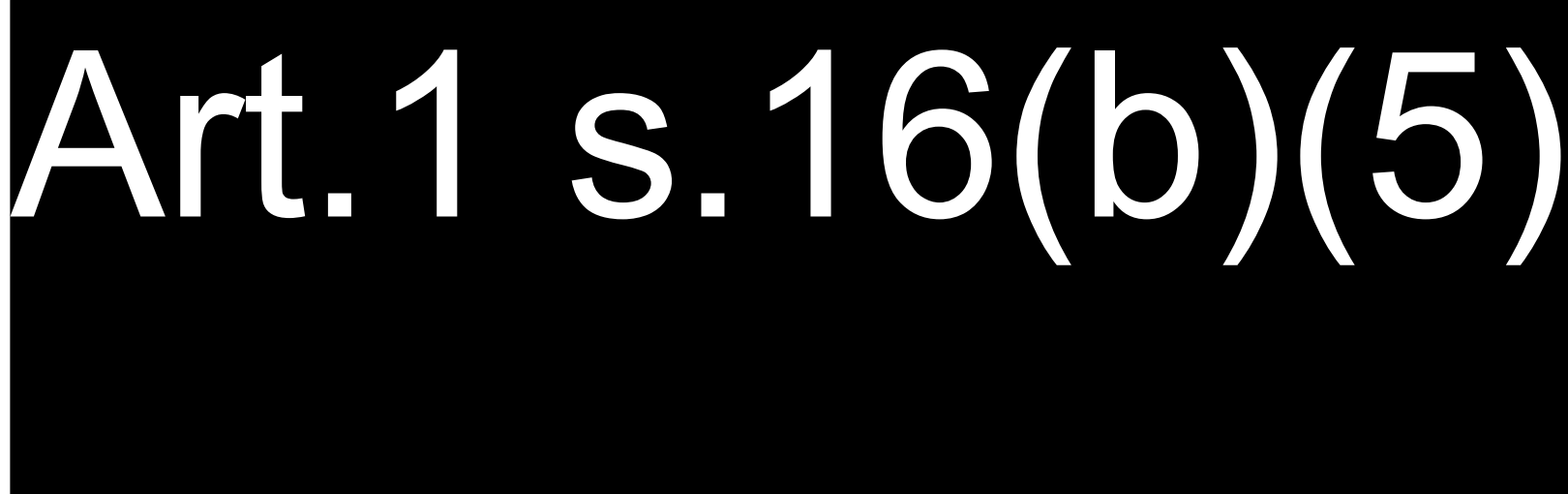

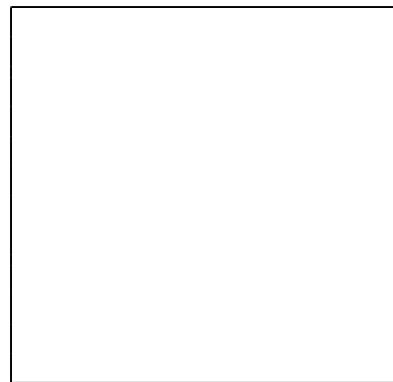
