On 9-28-18 at 0609 hours JSO Patrol Units along with JFRD Fire Rescue personnel responded to a "911" call at

2521 Orion St. where a black male victim (Demetrius Antonio Portee) was shot in the head by a known suspect (Shawn Jamaal Smith). After hearing the shot fired, witness/victim [REDACTED] walked out of a bedroom in the residence and saw the suspect (Shawn Smith) point the gun in her direction upon seeing her. She then fled back into the room, armed herself and fired a shot through the wall to scare off the suspect.

The victim was transported to UF Health where despite the efforts of Medical personnel he was pronounced deceased at 1302 hours by Dr. Koyzr.

The suspect was apprehended by officers from the Atlantic Beach Police Department after being alerted by a clerk at the Dunkin Donuts on Mayport Road. He was arrested for possession of a controlled substance and transported to the homicide office for an interview prior to booking.

Meanwhile, the other witnesses present inside the Orion Street residence were interviewed and identified Shawn Jamaal Smith (aka. "SS") as the shooter.

After acknowledging that he understood his Miranda rights Shawn Smith agreed to speak with detectives. [REDACTED]

The suspect was arrested on 10-28-2009 and charged with Armed Robbery with a Firearm, Aggravated Assault with a Deadly Weapon, and Possession of a Controlled Substance with Intent to Sell. He was found guilty of all charges and sentenced to the Florida State Prison.

The suspect was escorted to the PTFD and booked for the murder of Demetrius Antonio Portee.


