On 07-19-2018 at 1506, JSO patrol officers were dispatched to 900 Broward Road, Apartment #96 (Waters Edge Apartments) and located the victim, Jessie Sumlar IV, deceased. The victim had been stabbed multiple times. The victim's door was locked upon police arrival and the victim's car keys, vehicle, bank card, and cellular telephone were all missing.

On 07-19-2018 at 1830, JSO conducted a media briefing that included a B.O.L.O. (Be On the Look Out) for the victim's missing vehicle.

On 07-20-2018 at 0905, a JSO patrol officer was dispatched to a burned vehicle. Detectives later confirmed this was the victim's missing vehicle. The vehicle fire was ruled an Arson by the Fire Marshall.

The victim's missing bank card was used at several A.T.M.'s (Automated Teller Machines) in the downtown Jacksonville area between 07-17-2018 and 07-18-2018 until the funds were exhausted and the card was shut down. Video was obtained at several locations that showed the suspect, using the deceased victim's bank card to access/ attempt to access the victim's bank account. The video also shows the suspect driving a vehicle that matches the exact description of the victim's vehicle.

The suspect's DNA was discovered intermingled with the victim's DNA, inside of the victim's residence (crime scene).

The suspect's fingerprint was discovered in blood, inside of the victim's residence (crime scene).

When the crime scene was processed, a shoe print was discovered in blood. After a search warrant was executed at the suspect's residence, a shoe with a tread-pattern consistent with the shoe print in blood at the crime scene was discovered.

During an interview, the suspect adamantly denied knowing the victim or even being in the victim's residence.

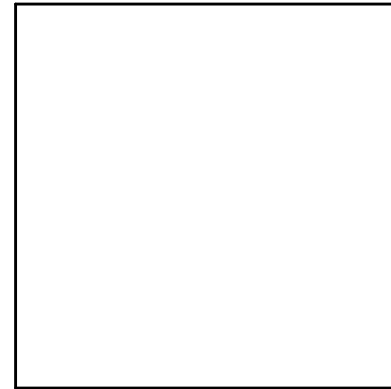
