On Friday, 06-15-2018, at 1401 hours, JFRD Fire/ Rescue personnel along with JSO officers responded to 2275 Cavalry Boulevard to a possible murder/suicide. Upon arrival the initial investigation indicated the potential suspect (Gerard Stewart) had called **FSS 119.071(2)(m)(1)** stating he had killed his wife (Julie Ann Stewart) and placed her body in the trunk of his car.

FSS 119.071(2)(m)(1) then notified police who arrived and were observed by Mr. Stewart. Mr. Stewart then pulled his car out of the garage, and into the driveway so the police would have access to it. He then returned to the residence **119.071(2)(c), F.S.**

119.071(2)(c), F.S. Mr. Stewart ingested a large number of pills in an effort to kill himself. The attempt was unsuccessful and after several hours he was taken into custody by SWAT personnel.

Mr. Stewart was transported to UF Health hospital and admitted for observation under the Baker Act.

On Monday 06-18-2018, Mr. Stewart was transferred to the PTFD after being released from the hospital. He was escorted to the Homicide office and advised of his miranda rights which he acknowledged understanding and agreed to answer questions.

Mr. Stewart **119.071(2)(e), F.S.**

Mr. Stewart was then escorted back to the PTFD and the Murder charge was added-on.

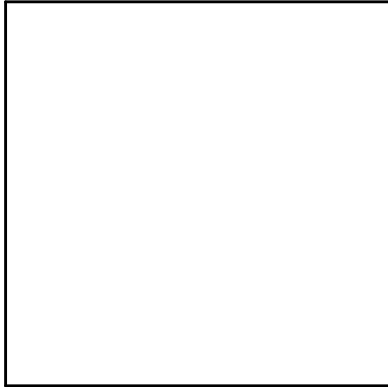
