On Tuesday, 06-19-2018, at 0905 hours, the witness, FSS 119.071 (2)(m) Upon arrival, FSS 119.071 (2)(m) realized the victim's 2006 silver Mercedes Benz was not at the residence. FSS 119.071 (2)(m) knocked on the front door of the residence and Marcus's bedroom window in an attempt to make contact with him. FSS 119.071 (2)(m) then walked to the rear of the residence. FSS 119.071 (2)(m) discovered the back door was unlocked. FSS 119.071 (2)(m) entered the residence via the unlocked door. FSS 119.071 (2)(m) walked through the residence in an attempt to locate to Marcus. While walking through the residence FSS 119.071 (2)(m) entered the master bedroom and found the victim, Voncile Heath, deceased on the floor lying in a pool of blood. FSS 119.071 (2)(m) immediately contacted police. The scene was secured by officers and witnesses were detained. Homicide detectives were called and responded to the scene.

At 1120, I arrived on scene; I was given a brief synopsis by Detective Griffis who arrived on scene prior to this writer. I learned that the victim was inside deceased and her 2006 Mercedes Benz and her son/suspect were missing. According to FSS 119.071 (2)(m) the victim doesn't allow anyone to drive her vehicle. There were no signs of forced entry into the residence.

My investigation revealed 119.071(2)(c), F.S.

119.071(2)(c), F.S.

Several officers from the Maryland State Patrol attempted to stop the suspect on Interstate 95. However, the suspect was able to elude the officers and avoided capture. The suspect then crossed the state line into Delaware, abandoned the victim's vehicle and attempted to elude the police on foot. After a brief foot pursuit, the suspect was taken into custody. 119.071(2)(c), F.S.

On 06-20-2018, Detective Chandler and I, along with Crime Scene Detective S. Wells traveled to Delaware to speak with Marcus Heath and to process the vehicle for additional evidence. 119.071(2)(c), F.S.

On 06-20-2018/1405: Detective Chandler and I interviewed Marcus Heath in Newark, Delaware. I advised Heath of his Constitutional Rights via a rights form. Heath signed the rights form and advised he understood his rights. 119.071(2)(e), F.S.

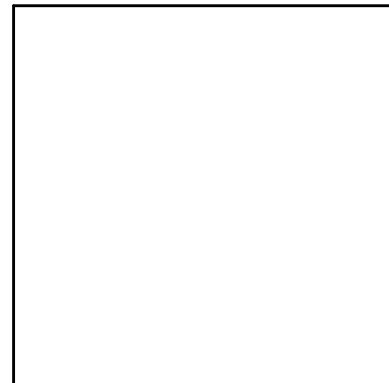
