Your affiant is a member of the Jacksonville Sheriff's Office and has been so employed for twenty (20) years. Your affiant is presently assigned to the Homicide Unit and has been in that unit for 12 years. Your affiant has received training in death investigations and recognition and identification of blood evidence and/or evidence relating to homicide investigations.

Your affiant is currently assigned to the homicide investigation of Quartz Walden which was discovered on 01-15-2019 at 6203 Merrill Road, Jacksonville, Florida 32277.

On 01-15-2019 at 1350 hours, patrol units with the Jacksonville Sheriff's Office responded to 6203 Merrill Road, in reference to an individual being shot. Upon arrival, the victim was located deceased on the west side of the building suffering from multiple gunshot wounds.

During the course of your affiant's investigation, multiple witnesses reported a black male (suspect), dressed in a black hooded sweatshirt and black pants walking west, away from the scene, after hearing multiple gunshots. Video surveillance was obtained from several businesses in the vicinity of the murder. In one camera angle from a nearby store shortly before the murder, the victim appears to be in a verbal altercation with a white female who was wearing a tan and cream stripped sweater with blue pants. The white female's identity was obtained from witnesses. The witnesses identified her as Kyrie Jorris (co-defendant.) Jorris is observed leaving the store and walking rapidly in the direction of her home at 2821 Searchwood Drive.

A few minutes later in another video surveillance, the suspect, Shawntell Charles Bryant, in the same described clothing, is seen walking in the direction of the victim with Jorris and another white female, [REDACTED] (witness) shortly behind the suspect; all three were on foot. Additionally, surveillance video in the area shows the victim walking to the side of structure of 6203 Merrill Road. The video surveillance further shows that the suspect dressed in a black hooded sweatshirt, black pants, and slides walks straight to the location of the victim. The suspect walks from the crime scene in the direction to 2821 Searchwood Drive which is located approximately one block away. All video surveillances demonstrate that Jorris and Bryant are on foot.

A witness stated he observed the co-defendant, Bryant, two white females (later identified as Jorris/suspect and [REDACTED]) walking in the direction of 6203 Merrill Road. One of the white females walking behind the co-defendant at the time of the murder was Jorris (suspect) wearing the above described clothing. All of these statements match video surveillance retrieved. The witness heard gunshots and observed the cosuspect walking from the direction of the gunshots. The suspect was described and later identified in a photospread by this witness.

The video surveillances obtained only shows Bryant (suspect) wearing a black hooded sweatshirt and black pants at the time of the murder.

Your affiant interviewed the suspect, Kyrie Jorris. [REDACTED]

Your affiant interviewed the witness, [REDACTED] said she was walking with the suspect and the co-defendant towards the area of the shooting. She said the suspect, Jorris pointed the victim out to the co-defendant as the person she had a previous altercation with. She said the co-defendant ran towards the area where the victim was walking. [REDACTED] said she heard multiple gunshots in the area where the co-defendant and the victim was. She stated she did not see anyone in the area prior to or after the shooting other than the suspect and the victim.

The suspect was arrested and transported to the PDTF.

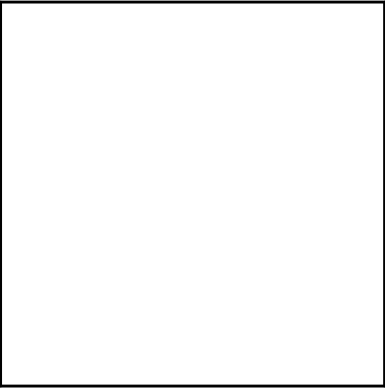
