separately and that Mr. Trevor Gray (Victim 1) succumbed to his injuries after being transported to Memorial Hospital after sustaining several gunshot wounds to his person.

Throughout my investigation it was determined Gray, **Sector** and **Sector** had an altercation with Mr. Izhaan Scott (Suspect) at 2615 St. Johns Bluff Rd. S. (Kangaroo Gas Station). During the altercation, **Sector** and **Sector** got into a fist fight in the parking lot, which was recorded on **Sector** cellphone. After the fight Gray, **Sector** and **Sector** entered Gray's **119.071(2)(h)** and left the parking lot travelling north bound on St. Johns Bluff Rd. S. Scott then entered his silver Toyota Avalon (FL: CPMD60) and pursued them to the intersection of St. John's Bluff Rd. S. and Theresa Dr. Gray's vehicle was at a stop and Scott's vehicle pulled along the driver's side of Gray's vehicle. Gunfire then came from Scott's passenger side striking Gray's driver's door and subsequently striking Gray.

While observing the scene (9) 9mm shell casings were located in the intersection of St. John's Bluff Rd. S. and Theresa Dr.

this incident.

During this investigation Scott was positively identified through the use of several investigative tools. Scott was contacted and detained and transported to the Police Memorial Building for interview. Prior to interview, Scott's Miranda Warning was reviewed with him and he stated he understood and was willing to speak with me without the presence of counsel. As the entire interview was recorded door to door the following is a synopsis of the statements made during interview. Please refer to the interview recording for complete details.


