On August 11, 2018, seven year old Heydi Rivas Villanueva ("Villanueva") was shot and killed in the 7900 block of 103rd Street in Jacksonville, Florida. Villanueva was sitting in the back seat of her parents' car when she was innocently caught in an exchange of gunfire. The gunfire exchange was caught on surveillance video ('Surveillance Video").

The Surveillance Video captures the recognizable identities of two of the men involved in the gunfire exchange, one in a reddish maroon shirt and the other in a white shirt.

On Saturday, August 12th, the Surveillance Video was released by the JSO to the media and information regarding the above-described men depicted in the Surveillance Videos was solicited from the public.

Subsequent to the release of the Surveillance Video, multiple calls were received by the JSO from people who identified one of the two men in the Surveillance Video as Trevonte Montie Phoenix ("Phoenix"). [19.071(2)(6), F.S.

On Monday, August 13th, Phoenix willingly came to the PMB and agreed to an interview. During the interview, Phoenix identified Abrion Price as the other male with him in the video.



According to law enforcement databases and the website of the Florida Department of Corrections, Abrion Maurice Price was adjudicated guilty in 2015 (18 years old) for the sale of cocaine, a second degree felony (Arrest Date of 06.20.2015).

According to law enforcement databases, Harris has been adjudicated as a juvenile delinquent for the following offenses: battery in an inmate detention facility, possession of a weapon or ammunition by a Florida delinquent, and burglary on May 18, 2016.

Based on the above detailed facts, Phoenix and Price have committed the offense of second degree felony murder; Price has committed the offense possession of a firearm by a convicted felon, and Harris has committed the offense of possession of a firearm by an adjudicated delinquent.

On Sunday,8-12-2018 an arrest warrant was issued by Circuit Judge Marrianne Aho charging Trevonte Montie Phoenix with Possession of a Weapon or Ammunition by a Florida Delinquent.

On Monday, 8-13-2018 Trevonte Montie Phoenix surrendered at the PMB on the above warrant. 119.071(2)(e),

Trevonte Montie Phoenix was escorted to the PTDF and booked on the warrant.

Afterwards, three additional arrest warrants were prepared and issued by Circuit Judge Marrianne Aho charging Trevonte Montie Phoenix with Felony Second Degree Murder, charging Stanley Tyron Harris with Possession of a Firearm by a Juvenile Delinguent found to have committed a felony act, and charging Abrion Maurice Price charging him with Secon Degree Felony Murder, and Possession of a Firearm by a Convicted Felon.

Afterwards, Stanley Tyron Harris was apprehended by detectives from the Criminal Apprehension Unit and transported to the PMB. He was interviewed 119.071(2)(e), F.S Stanley Tyron Harris was then escorted to the PTDF and booked on the warrant.
