On 02-21-2019 at 1515, Officers from the Jacksonville Sheriff's Office were dispatched to 4301 Confederate Point Rd. #243 in reference to an allegation of a battery.

The 911 caller, **119.071(2)(c)**, advised that **119.071(2)(c)**, London Woodworth (suspect), killed his girlfriend (Andrea Petrick, victim) and that she was outside in their vehicle. **119.071(2)(c)** advised she was going to walk downstairs to see if the victim was in the vehicle and the suspect told her that he did not want her to see. The suspect told **119.071(2)(c)** (witness) that she could verify what he had done. **119.071(2)(c)** walked downstairs to the parking lot with the suspect where he opened the rear driver side door to the vehicle and she observed the victim on the floorboard. The victim appeared to be wrapped in a blanket. **119.071(2)(c)** touched the victim's neck to check for a pulse and she was cold to the touch and visibly deceased. She described her as gray in color.

The suspect made several statements to the witnesses **119.071(2)(c)**

119.071(2)(c) asked the suspect when he killed the victim. He told her that he killed her early this morning and had been driving around with her all day. The suspect continued to state that **119.071(2)(c)**

119.071(2)(c) stated that the suspect snuck into her home today at 0300 and woke her up to borrow money. She gave him \$20.00 and asked him to leave due to her being tired. The suspect told her, "you know I'm going to be going to prison soon," (referencing a separate pending court case). She told him not to worry about that and asked where the victim was at. He told her that she was downstairs in the car waiting for him. **119.071(2)(c)** did not see the suspect again until approximately 1400 hours.

I interviewed **119.071(2)(c)** about what the suspect told her and she repeated the same statements to me that the suspect told her. I asked her about his mental health history and drug usage. She stated that he has been diagnosed with bipolar schizophrenic and was on medication for that illness until he turned 18 years of age. She advised that he stopped taking the medicine at that time and that he seemed to be fine. She added that he would use heroin off and on but that he did not exhibit any visible signs of his illness. Recently, in the past six months, the suspect has started using "crystal meth" very heavily. Since using crystal meth, his behavior has become increasingly worse. She also stated that the suspect and the victim used to use the drugs together.

I attempted to interview the suspect and he stated that he did not want to make any statements without his attorney.

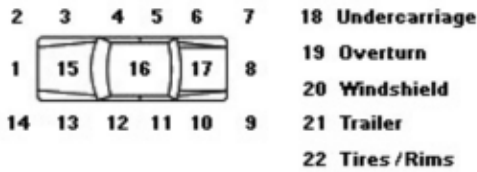
