ADDITIONAL INFORMATION

On 10/01/18, at 0816, I was dispatched to 3772 Zoo Parkway in reference to a possible death. Upon my arrival, I met with Officer K. W. Browning 5463 and the Witness, Mr. Cain.

Officer Browning stated personnel from Engine 48 were present earlier (run number 115158). Officer Browning stated the victim was deceased. Officer Browning placed crime scene tape around the scene.

I contacted the witness, who stated, he went down by the water to catch bate to go fishing. The witness further stated he walked under the bridge to catch bate when he saw the victim lying on her back wearing only a bikini top.

I inspected the victim who appeared deceased. The victim appeared discolored around the face and left side of her body. The victim only had a bikini top that was pulled down just below her breast. I noticed there was water on the victim's belly. Currently the tide was low away from the victim. When the tide is high, the water covers most of the area past where the victim was found.

Sgt. Vanaman 6332 was notified of the incident. Homicide responded to the incident.
