Upon arrival, I was flagged down by three black males that were pointing up at the top of the stairwell of building 37-40, who advised that someone was shot and laying at the top of the stairwell in front of Apartment 40.

JFRD Engine 22, Rescue 22 arrived on scene. JFRD Lt. Weakland pronounced the victim deceased at 1457 hrs.

A perimeter was established.
